
- We bring together multiple entities, become enablers and/or anchors for projects that impact society at large, in the areas of Education, Water Conservation and Disaster Relief

Much like the the last decade, the 2022 edition was significant in raising funds via the World 10K Run platform. This year we witnessed an increase in the ticket size of donations, reassuring us of society's acknowledgement of the vital work being done by India's social sector, and that this platform provides a honourable means to make a difference.

With only 60 days to fundraise, as against the usual 120-day window, we were apprehensive. However, our fears were proven unfounded. The amazing response from the Civil Society Organisations (NGOs), individual fundraisers and companies resulted in INR 3.03 crores being raised in a span of 2 months.

This edition also saw a greater involvement from Bengaluru's run clubs, with an increasing number of runners taking up a cause to donate/fundraise.

Our association with this flagship event ends with this edition. However, we wish the platform grows from strength to strength, in the coming years, in supporting the social sector.



Our collaboration with Biome Environmental Trust and Friends of Lakes to provide end-to-end solutions in water conservation saw us achieve many milestones, with generous funding from our sponsors.

- 51 Rainwater Recharge Wells (RRW)
 made in Defense Campuses of
 Bangalore and 6 RRWs at the Navy
 Campus of Madh Island, Mumbai each
 3 ft in diameter and up to 15 ft in depth,
 collecting over 12 lakh litres of
 rainwater every year.
- A defunct, abandoned, traditional well restored, and now providing over 30k litres of water everyday.
- Fencing of the Lotus Pond at Lalbaug Botanical Gardens - for visitor safety and prevention of casual garbage disposal.
- Rainwater Harvesting Systems (RHS) set up in 2 schools each at Bangalore, Bidadi and Pune, benefitting over 2,500 school children.
- Feeder Canals of two lakes revived in Mulbagil Taluka of Kolar district, and tree plantations undertaken to strengthen the lake bund, thus helping over 40 farmers grow two crops a year, and providing water for their livestock.
- Over 15 families of the Mannu Vaddar Community provided livelihood as a result of the RRW and well restoration work during the year.
- 30 women from villages around the lake provided employment during the Feeder Canal Revival work.

EDUCATION

Infrastructure enhancement in Government schools is something we believe in and strive for - with unwavering support from our corporate sponsors.

- 3 Government girls higher secondary schools in Madurai provided with:
 - A Computer Learning Centre equiped with desktops, printer, projector, air conditioners, tables and chairs.
 - Archery Kits for training of promising students who participated in State and National levels and won medals.
 - · A RO Plant.
- One year sponsorship, including residential costs, for 30 students at Shanti Bhavan School.
- Funded training for 30 students at Nettur Technical Training Foundation (NTTF), enabling better chances of career placements.
- A Community Computer Learning Centre with NIIT certified teachers, set up for children of lower income families of Karisandra, Bangalore.

22 CSOs/NGOs utilized the Digital Wishtree and raised Rs 6.22 lakh through 345 donors

REACHOUT

Supported 6 organisations in their strategy for growth, enhancing their fundraising and communications, resulting in a 25% growth in their fundraising during the financial year

A Daan Utsav fundraising event that received a resounding feedback from CSOs/companies and donors and succeeded in raising INR 22 lakh. An evening of music and food for the 600+donors who supported the participating CSOs.















OTHER PROJECTS

- 16 women micro farmers, in dire post-pandemic financial constraints, provided with fruit tree saplings through Arohana Grameena
 Abhiruddi Samsthe in Kolar Distrist
- 6 sewing machines provided to women for increased income generation, and 6 new desktops provided to the Community Learning Centre run by Swabhimaan at Viveknagar.
- Two months ration donated to Ashraya Seva Trust to help feed 50 elderly residents.
- 40 individuals from the LGBTQ community provided training in starting and managing their own businesses
- 20,000 hours of volunteering for lake cleaning, tree plantations, spot beautification, sanitization of Government Schools, done by employees from over 7 companies.
